**Booth assignments given April 25, 7-9:30 a.m.** at Hwy 98 & Marine Street. Traffic will be one way from Hwy 98 down Marine Street. You may not change booth assignments. All tents & shelters must be secured by weights. Booths are on pavement. Vendors must supply all their own

necessary equipment and are responsible for the required government & health & safety requirements.

Please be quick and courteous and avoid blocking the street while unloading and reloading. All vehicles must be clear of the vendor area and parked in a designated parking area by 9:30 am unless you have made prior arrangements. Festival hours are 10-6. Please plan to keep your booth open 10-6. You may break down your booth after the venue has closed.

**ABSOLUTELY no moving vehicles are allowed on Marine Street after 10 am until the end of the festival and the street is officially re-opened by the festival staff. No exceptions. Citations will be issued for noncompliance with this advisement.**
